Dear Doug and Heather,

**“I wish abortion would just go away.”** I remember saying this 10 years ago. Abortion seemed like such an immense problem. I didn’t want to have to understand or deal with it. I knew it was wrong. I wanted it to stop, but I didn’t want to have to do anything to help stop it.

All of this changed the day in August 1997 when I saw pictures of what abortion does to a baby. After wiping away the tears, I realized people need to see the same pictures I had seen! Ten months later I committed myself to full-time pro-life work.

I realized right away that I would have to change my lifestyle in order to have a chance to save the lives of the unborn. (Abortionists make lifestyle changes—even risk their lives—to **slaughter** the unborn.) One of the biggest changes was that I needed to raise my own salary in order to help save lives (like most full time missions work). It was fairly easy in the beginning—I was 25 years old, single and had no mortgage.

My first 7 years of pro-life work were spent with a great organization called the Center for Bio-Ethical Reform (CBR). In 2005, I began work with Justice for All (JFA), whose principle focus is to reach students with the truth about abortion, and to train them for leadership in future generations.

This is accomplished through the presentation of a large, museum-quality, outdoor photo exhibit that is placed on college and university campuses. We show the JFA Exhibit to thousands of students every year (caution, some of the images are graphic). Please read the enclosed campus report.

Additionally, hundreds of high school and college students are trained every year by JFA to present their pro-life beliefs and values to fellow students. Trained students join us on college campuses to practice sharing the JFA Exhibit with students who disagree.

I direct JFA’s logistical support which means I coordinate with student clubs the reservation of all outdoor and indoor Exhibit locations; help arrange housing, meals and transportation for JFA staff and volunteers; and recruit and supervise volunteers to set up and take down the Exhibit structure.

I also oversee JFA's information technology which means data collection, entry, analysis and reporting of contacts' personal information from each Exhibit event. I also manage all office and field computers, fax machines, copiers and printers; coordinate and manage the email system.

Thankfully, I am not doing this alone. JFA has a staff of seven who team up to reach hundreds of thousands of students each year. JFA's Executive Director is David Lee, who regularly speaks and teaches in churches and Christian schools around the country.

And 9 years later I have a great family that deeply supports my work and even attend some of the outdoor campus presentations. My wife Trudy and I are blessed with four wonderful children; Victoria (10), Sophia (6), Jacquelyn (3), Genevieve (2) and Levi (4 months).
