## Repeat Work and Sharing the Brochure

Follow-up with those that we train through Seat Work and Feet Work is a major emphasis at Justice For All. It is through following up with them that we learn of their Repeat Work. Repeat Work is when volunteers, trained through Seat Work and Feet Work, use their JFA training to have their own conversations away from a JFA sponsored outreach. Repeat Work can be as simple as sharing the JFA Exhibit Brochure, pictured below, with a family member, friend, or acquaintance.

We have heard of quite a number of lives that have been saved as a result of pro-life people lovingly sharing our little nine-inch JFA Exhibit Brochure with abortion-minded women. Let me know if you would like copies. I would also be glad to give you ideas on how to start the conversation and how to share the information in the brochure in a loving way.

Here are a couple of updates from people we have trained who have done Repeat Work. You may recall the crash-course training that JFA staff member Catherine Wurts gave to Amanda at Wichita State University.
