

MAY 2010 MISSION TRIP

Thank you for your interest in Justice For All's May 2010 Mission Trip. We are delighted that you are considering giving of your time to help **make abortion unthinkable** in Sunny California! We'll travel to UC San Diego and Pasadena City College from May 22-29.

1. What is the schedule (tentative) for JFA's May Mission Trip?

Saturday, May 22

- Fly into LAX between 11:00am-3:00 p.m.
- Travel to San Diego; Check into hotel

Sunday, May 23

- Morning Church Services
- ADD Seminar (12-5:30)

Monday & Tuesday, May 24-25

• Exhibit outreach at UCSD

Tuesday Evening, May 25

• Travel from San Diego to Pasadena; check into hotel

Wednesday & Thursday, May 26-27

• Exhibit outreach at PCC

Friday, May 28

- Fun Day at the beach
- Debriefing before dinner

Saturday, May 29

• Fly out of LAX (morning flights preferable)

2. How much does it cost to participate?

The outreach participation fee schedule is listed below. The fee will vary from \$350 to \$500 depending on double or quadruple occupancy for lodging (your choice).

Outreach fee schedule:

Options:	1	Double occupancy (May 22-29)	\$ 500
	2	Quadruple occupancy (May 22-29)	\$ 350

This fee <u>does not include</u> your airfare or travel expenses to/from California. Travel expenses are defined as airfare, bus fare, rental car, fuel, hotels, food, tolls or any costs associated with your trip to and from California for the exhibit outreach.

3. What does the participation fee cover?

- a) Lodging for 7 nights from May 22-29
- b) 3 Meals per day except a few travel meals, i.e. traveling to San Diego and Pasadena
- c) Ground Transportation (If you will have your own car for 8 days, you can deduct \$90 from the fee.)

4. Do I need to send the entire fee with my completed Application?

No. Send a \$50 deposit (non-refundable) with your completed Application as soon as possible but no later than March 27. The remaining balance is due by May 1, 2010.

5. What if I can't afford it? Do I have to pay for the trip out of my own pocket?

No, JFA can assist you with fundraising once you are accepted for the trip. Using our methods and materials, past participants have raised an average of \$600 for a one-week trip, although there are no guarantees. Any funds you raise above your participation fee will be used to reimburse your travel costs. Additional funds raised above your participation fee and travel costs will go toward the JFA Exhibit Program. All funds must be raised by May 1, 2010.

6. If I need to fundraise, how soon do I need to start the process?

Once you have submitted your Application and deposit, you will be notified within one week (no later than April 2) if you have been accepted. Upon acceptance, you are encouraged to start the fundraising process immediately by requesting a fundraising packet (deadline is April 5, 2010).

7. Yes, I want to help make abortion unthinkable in Southern California this May. What do I need to do?

a) Complete the <u>Application</u> online and email it to <u>tammy@jfaweb.org</u>. Indicate which Option (1 or 2) b) Also mail a signed copy of the application with a picture of yourself and your \$50 deposit to Tammy at the address below. JFA must receive your completed application and deposit <u>no later</u> than March 27.

Space is limited to 25 participants so be sure to submit your application right away to ensure a spot for this life-changing opportunity!

8. Should I go ahead and book my flight to save money?

No. The exact dates are still tentative. You must first apply and be accepted for this trip. Please check with me before making any flight arrangements (we need to coordinate arrivals/departures).

Important Dates:

March 27 Deadline to submit signed Application and deposit (received by JFA)

April 5 Deadline for accepted participants to request packets to start fundraising

May 1 Deadline for Fees to be paid in full
