Dear Friend,

Imagine if someone said to you, "Have you had a chance to start a conversation about *slaughter, death, guilt, blood, and gore* recently?"

I think that's how my frequent calls to "start a dialogue on abortion" come across to most people. Along with the ugly subject matter, discussion of abortion is often marked by debate, disagreement, hurt feelings, and offense. Most people can't stomach these interpersonal companions of abortion any more than they can stomach the blood and gore of the subject itself.

Still, if we really believe unborn children are human beings who matter, we *must* be ready to engage the topic. Silence isn't neutral. Being silent takes a particular position on the value of the unborn. It says they don't deserve our best efforts to help them. If we say we're pro-life, and we don't seek to help people think clearly about abortion, can we really say we're pro-life after all?

That's why my book, *Common Ground Without Compromise*, brings hope to the person who genuinely cares about the injustice of abortion. While it's impossible to remove all of the negative aspects of the abortion topic, common ground removes the hurtful debate elements and replaces them with a friendly atmosphere of dialogue. And dialogue isn't just easier to stomach. It also makes all parties *want* to engage. One pastor from Houston, Texas recently illustrated this:

I'm a bi-vocational pastor. In addition to my ministry responsibilities, I teach K-5 music in an elementary school. At church, people value my insight on moral and spiritual issues. At school, my thoughts are just the opinions of another teacher. Because of this I feel the same fear as others when engaging in conversations about such weighty topics as life or choice. I'm secure in my viewpoint, but I don't want to merely offend. The day after reading Common Ground Without Compromise the topic of abortion came up during a school lunchroom conversation. Rather than keeping quiet as before, I fully engaged in the conversation. I felt confident, but more importantly the content of Stephen's book enabled me to be compassionate as well.
